ACCEPTANCE OF DAYCARE POLICIES ASSUMPTION OF RISK, RELEASE AND INDEMNIFICATION

I have read the Frequently Asked Questions (FAQs) handout about daycare policies and procedures at Blue Collar Doghouse (BCD). By my signature below, I accept these policies and agree to comply or be subjected to temporary or permanent expulsion. These policies include but are not limited to:

- I understand that my dog must be at least 16 weeks old, to begin daycare.
- I understand that my dog must pass a 90-minute temperament trial prior to his/her acceptance into daycare. I understand that this trial will take place from 7:30 – 9:00 am on a date scheduled by BCD, once my application is complete and my dog's vaccination records are received.
- I understand that my dog must be vaccinated for Rabies, Bordetella, and DHPP prior to acceptance into daycare, and that I am responsible for providing updated vaccination records thereafter.
- I understand that my dog must be spayed or neutered by no later than nine (9) months of age, OR SOONER if the staff at BCD notice signs that he/she is entering sexual maturity (whichever date comes first).
- I understand that my dog should not attend daycare if he/she shows any signs of illness or infestation that could be transferred to other dogs. This includes but is not limited to unexplained diarrhea, vomiting, coughing, parasitic infestation, papilloma virus, lethargy, or any suspicious change in health and/or behavior.
- I understand that my dog must be treated for fleas on a monthly basis, year-round, to attend daycare.
- I understand that all daycare packages I choose to purchase at discounted rates are non-refundable and non-transferrable for any reason other than the death of my dog.
- I understand that all daycare packages will expire if my dog is absent from daycare for more than one year.
- I understand that I will be charged a substantial late fee if I fail to pick up my dog from daycare by 7 pm.
- I understand that daycare rates are tied to the duration of my dog's stay, and that my rate will automatically convert to the next higher scale if I miss the cutoff time for any particular visit.
- I understand that I must be available to pick up my dog on short notice, in the event of an illness or injury. I have provided emergency contacts that can be contacted in the event of an emergency, to pick up my dog.
- I understand that my dog's behavior in daycare may change over time, and that BCD may determine that he/she is no longer suitable to attend daycare, at any time, with or without advance notice.

I hereby place the dog(s) referenced below in the care and custody of Blue Collar Doghouse (BCD) for daycare services on an ongoing, intermittent schedule.

I understand and acknowledge that dog behavior can be unpredictable. I accept that my dog(s) may be sickened, injured or killed while in the care of BCD, either inside the daycare facility, anywhere on the premises, or while entering/exiting the building.

I assume all risks related to the provision of BCD's services (with the exception of gross negligence), including but not limited to disease, illness, injury, death, theft, escape, fire, natural disaster, or harm to person(s), dog(s), or property.

I agree not to sue and to release BCD, its owners, agents, employees and contractors from liability for all actions, claims, or demands for injury, loss or damage, regardless of the cause. I agree to bear any and all damages, losses, liabilities, demands and expenses, including legal and professional fees incurred as a result of any damage caused to or by my dog(s). I also agree to defend and hold BCD harmless for any liability thereon.

In the event of a veterinary emergency, I authorize BCD to transport my dog(s) to a licensed veterinarian. I agree to pay all costs or fees incurred with respect to these veterinary services.

I agree that my dog(s) may be videotaped or photographed while in the care of BCD, and that BCD will own the rights and proceeds of such tapings or photographs.

I understand that security cameras inside BCD may record my communications and actions at any time (with the exception of the public bathroom).

I understand and accept that BCD may impose a more frequent vaccination schedule than is recommended by my personal veterinarian. I give BCD permission to contact my veterinarian to verify vaccination dates, as well as any health and/or behavioral issues. I give consent to allow my veterinarian to release this information to BCD.

I acknowledge that falsifying, misrepresenting, or deliberately withholding information about my dog's temperament, health, vaccination records, history of aggression or other potentially dangerous behavior may result in immediate and permanent dismissal from daycare, without refund.

I understand that this document is a release of liability and contract with BCD, and that I am signing this agreement of my own free will.

I understand that the terms of this Agreement shall not be modified except in writing and signed by BCD. I understand that this Agreement shall be governed by the laws of the State of Washington, which may change without my knowledge.

I understand that I will receive a digital copy of this binding Agreement, emailed to the address I have provided on my Application, and for personal records.
